

**French Travel Specialists
40-LOVE CONTRACT**

Air Transportation: Travelers who purchase a package will only include the land portion. However, if 40-LOVE accommodates you or directs you to a travel agent or airline company, 40-LOVE will not be responsible under any circumstances of any delays or airline changes

due to different impossibilities or non-suitable business negotiation between the travel or any airline and 40-LOVE.

Documentation: A valid passport (visa if necessary) are required for travel outside of the USA and around the world, it is the responsibility of each traveler to obtain and carry proper documents according to their citizenship and wherever their destination might be. 40-LOVE will not accept any traveler without the proper documents at departure and document must be valid for at least 6 months to a year from the departure time.

40-LOVE will have the right to refuse any passenger and apply the conditions of cancellation of the 40-LOVE contract if the traveler's documents do not complete the above conditions.

Prices: All prices are subject to change at any time due to international currency fluctuations such as accommodations, meals, transportation, airlines, or any items included in the package chosen before purchased in full by the traveler. Once the full payment on the package chosen has been fulfilled by the traveler, French Travel Specialists and its entity 40-LOVE Inc. will ensure every item purchased at the same rate. In the event that the traveler requests other items (accommodations extensions, added items to the itinerary purchased etc.) such items added to the package chosen will be quoted at the exchange rate at the time of purchase. All prices quoted are per person and based on double to quadruple occupancies (single occupancy is available upon request at extra charge as well as airfare)

Reservation: All names must be final 60 days prior to departure for the different packages.

Reservation & Deposit: A deposit of 50% of the total price of the package chosen per person is required at the time of your reservation or booking. The entire remaining balance due must be paid no later than 60 days prior to departure or arrival. In the event of a cancellation not related to the cancellation paragraph, the cancellation fee will be your deposit.

Cancellation: A cancellation fee of your deposit will apply if the cancellation occurs 61 days or more prior to departure.

A cancellation fee will apply if failure to make the final payment to 40-LOVE as of 61 days prior to departure, 40-LOVE will have the right to cancel in full and total forfeiture of deposit will occur at that time. If the cancellation occurs between 60 days and 51 days prior to departure, the cancellation will then be 60% of the complete price of the package(s) chosen. If the cancellation occurs between 50 days and 41 days prior to departure, the cancellation will then be 70% of the complete price of the package(s) chosen. If the cancellation occurs between 40 days and 00 day prior to departure, the cancellation will then be 100% of the complete price of the package(s). Cancellation request by the traveler by deposit must be made in writing to 40-LOVE INC., 208 Shoreham Village Drive, Fairfield, CT 06824 USA. The relevant date will be the date that 40-LOVE INC. received the writing cancellation notice (40-LOVE advises our traveler to use registered mail or dated telegram).

Booking Procedure: 50% of the total price of the package chosen will be asked per person for any booking. Payment is to be made in the form of a check, cashier check, or money order to 40-LOVE INC. The remaining balance is to be paid no later than 60 days prior to departure.

Travel & Automobile Insurance: Travel & Automobile insurance are not included in any of the packages chosen unless specified otherwise. 40-LOVE highly recommends the purchase of travel & automobile insurance as well as health insurance around the world. It is the traveler's responsibility to purchase his or her own insurance. If traveler do not carry any insurance through their trip, travelers will be fully responsible for cost, cancellation, or loss resulting from bankruptcy by traveler's refusal to purchase traveler insurance. 40-LOVE highly recommends all travelers to take a medical test prior to departure.

Traveler's Options: All items specified in each of the packages are arranged for all and each of the travelers who purchase a package through 40-LOVE. There are no obligations to participate at all events during the tour.

Responsibility: 40-LOVE is responsible for making arrangements with all the services included in the package such as transport, hotel, sightseeing and other items specified in the land package or any of the description package chosen.

Although, 40-LOVE is making arrangements for the services, 40-LOVE is not responsible for their manners, as they are independent contractors and not employees of 40-LOVE. Once one or more 40-LOVE packages have been purchased 40-LOVE is responsible for the packages sold to the individual who purchased the packages and to that individual only. 40-LOVE is not responsible for any cancellation of activities due to weather condition or other impossibilities beyond the control of 40-LOVE. 40-LOVE will try in its capacity to accommodate with comparable service if any change of itinerary of services would occur for any reasons beyond its control. If services and accommodations cannot be supplied due to causes beyond its control, 40-LOVE shall have no responsibility or liability. The liability of 40-LOVE with respect to the agreement shall in any event be limited to the total price paid by the traveler for the tour services provided under this agreement and shall not include any contingent, liability, or compensatory damages. Travelers will be responsible to his or her person or company occasion by accident, loss, or injury, and shall be the sole responsibility of each of the travelers and 40-LOVE will not be responsible for any accidental loss or injury to person or property. 40-LOVE reserves the right to cancel any trips and packages at any time and will not be responsible for such a decision.

40-LOVE will refund all deposits and final payments in the event of a cancellation if the cancellation is determined by 40-LOVE.

Parties Bound: This agreement shall be binding upon inure to the benefit of the parties hereto only, and shall not be assignable or transferable to any other person or entity without the prior written consent of 40-LOVE.
